ARTICLES OF INCORPORATION OF TRUE WEST TRADING CO.

97 JAN-2 AH10: 56

The undersigned persons, acting as incorporators of a corporation organized pursuant to section 607.0202, Florida Statutes, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be: True West Trading Co.

ARTICLE II

PERIOD OF DURATION: The period of duration of True West Trading Co. shall be perpetual unless dissolved under the laws of the State of Florida or changed in accordance with these Articles and the corporation Bylaws.

ARTICLE III

PURPOSE: This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV

AGGREGATE SHARES: The aggregate number of shares which the corporation is authorized to issue is 1,000,000, consisting of one class with no par value. The voting rights will be exercised in direct relation to the number of shares held by the single class established.

ARTICLE V

REGISTERED OFFICE AND AGENT: The street address and mailing address of the corporation's principal office as well as that of the initial registered office of this corporation is the same: 519 Turtle Hatch Road Naples, Florida 34103. The name of its initial registered agent at said address is J. Eric Konuk.

ARTICLE VI

BOARD OF DIRECTORS: The number of directors constituting the initial Board of Directors will be two and each shall serve as director until his successor is elected and qualifies under the Bylaws of the corporation. After the initial Board of Directors, the Board shall consist of such number of directors as shall be fixed and/or determined by the shareholders from time to time at each annual meeting thereof, at which time the directors are to be elected. The initial directors of the new corporation shall be the undersigned incorporators.

ARTICLE VII

BYLAWS: The Bylaws of True West Trading Co. may contain any restrictions on the transfer of the shares of stock of the corporation as well as the issuance of any bonds or notes.

ARTICLE VIII

CORPORATE EXISTENCE: The corporation's existence shall begin on the day these Articles are filed with the State of Florida and recorded at the office of the Department of State.
