LEONE, a natural person, competent to contract, does hereby make, acknowledge and file in the Office of the Secretary of the State of Florida, for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida and pursuant to the Florida General Corporate Act, these Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

The name of the Corporation shall be BLOCK ISLAND TRADING CO.

The principal office and mailing address of the Corporation is 1017

Lincoln Street, Hollywood, FL 33019.

ARTICLE II

GENERAL PURPOSE

The general purposes for which this Corporation is organized are:

- A) To buy, sell, trade, and manufacture of gem and semi-precious stones; and employ personnel for the purpose of or in connection with said business in every kind or character, and to do any and all things necessary and proper to effect such purpose.
- B) To carry on business at any place or places within the jurisdiction of the United States, and in any and all foreign countries, and to undertake, contract for or carry on any lawful business incidental to or in aid of, or advantageous in pursuance
