ARTICLES OF INCORPORATION OF THOMAS WRIGHT HEADLEY, P.A.

SECRETARY OF STATE TALLAHASSEE; FLORIDA

The undersigned, acting as incorporator pursuant to Chapters 607 and 621 of the Florida Statutes, adopts the following Articles of Incorporation:

Article I.

NAME

The name of this corporation is Thomas Wright Headley, P.A.

Article II.

PRINCIPAL OFFICE AND MAILING ADDRESS
