

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a corporation for profit under chapter 621 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the corporation is GISELE MARDY, M.D., P.A.

ARTICLE 2- PURPOSE OF CORPORATION

The corporation shall engage in the practice of medicine permitted under the laws of the United States and of the State of Florida

ARTICLE 3 - PRINCIPAL OFFICE

The address of the principal office of this corporation is 13740 SW 105 STREET, MIAMI, FL 33186. mailing address is the same.

ARTICLE 4- INCORPORATORS

The name and address of the incorporators of this corporation are:

ARTICLE 5 - PRESIDENT

The initial President of the corporation shall be GISELE MARDY, M.D., P.A. whose address shall be the same as the principal office of the corporation.
