

In accordance with our telephone conversation with Ms. Trevor, I am writing this letter along with the enclosed form of annual report and a check of \$ 150.00.


As you may note in the annual report form, the address was not correct. We could not figure out why the address was not corrected and we did never receive any renewal notice at all.
