ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
CNL HOSPITALITY ADVISORS, INC.

Pursuant to the provisions of Section 607.1003 and 607.1006 of the Florida Statutes, CNL HOSPITALITY ADVISORS, INC., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is CNL HOSPITALITY CORP.
2. The original Articles of Incorporation for the Corporation were filed on January 9, 1997, and assigned document number P97000002185.
3. By written consents executed as of October 22, 1999, the Directors have agreed that the Articles of Incorporation be amended to change the name of the Corporation to CNL HOSPITALITY CORP. Shareholder consent was not required.
4. Article I of the Articles of Incorporation is hereby amended to read as follows:


ARTICLE I

Name and Address

The name of this Corporation shall be CNL HOSPITALITY CORP. and its physical and mailing address shall be 450 South Orange Avenue, Orlando, Florida 32801.
