ARTICLE I - NAME

The name of this corporation is SYNDICATED DESIGN, INC. The mailing address of the corporation shall be 7450 Sparkling Lake Road, Orlando, Florida 32819.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100,000 shares of \$.01 par value common stock.
