

The undersigned, acting as incorporator of Electronic Sales Center, Inc. under the Florida Business Corporation Act, adopts the following articles of incorporation.

**ARTICLE I - NAME**

**ARTICLE III - COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on January 2, 1997.

**ARTICLE IV - PURPOSE**

#### **ARTICLE V - AUTHORIZED SHARES**

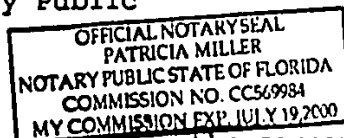
