**ARTICLE ONE - NAME**

The name of the corporation is KESTA, INC.

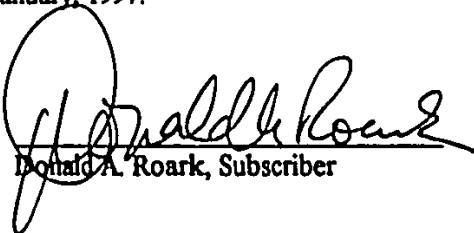
**ARTICLE NINE - BY-LAWS**
