2. That the Corporation was administratively dissolved by the Florida Department of State on the 4th day of October, 2002.
3. That the Corporation failed to file its 2002, 2003, 2004, and 2005 Annual Report or pay the 2002, 2003, 2004, and 2005 Annual Report filing fee within the time prescribed by Florida Statutes Chapter 607 because:
