ARTICLE I.

TALLAHASSEL, FLORIDA

CORPORATE NAME

The name of this corporation shall be: JAS TRAVEL & TOURS, INC.

ARTICLE II.

NATURE OF CORPORATE BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
