

ARTICLES OF INCORPORATION
OF

The undersigned Incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be: FINEST KIND OFFSHORE TACKLE, INC.

ARTICLE II. INITIAL REGISTERED OFFICE AND MAILING ADDRESS

The street address of the initial registered office of this corporation is 3565 S.E. St. Lucie Blvd., Stuart, FL 34997. The mailing address of this corporation is 3565 S.E. St. Lucie Blvd., Stuart, FL 34997.

ARTICLE III. CAPITALIZATION

The duration of the corporation is perpetual.


ARTICLE X. MEETINGS BY CONFERENCE TELEPHONE

ARTICLE XI. INDEMNIFICATION



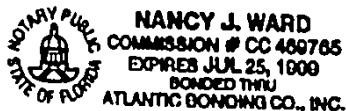
