

This office represents the above corporation and I am the registered agent. My client recently received your letter dated April 21, 1999 stating that the corporation has been dissolved and that \$900.00 must be paid in order to reinstate. Our client sent a check to our office made out to the Department of State (Check #1776) on April 7, 1998. This check was sent in without the Annual Report form (which they never received) and was inadvertently deposited into our office account on April 9, 1998 by a temporary secretary who was filling in at our office at that time. Neither my paralegal nor I were aware that the check ever arrived. As I am sure your office can appreciate, the months of March and April are very hectic with all of the annual corporate meetings. I have been practicing law for 22 years and, fortunately, I have never had this occur until now. I respectfully request that the reinstatement fee be waived so that we may immediately reinstate the corporation. Our clients are very responsible, hard-working young men who are establishing a solid business and a good reputation and we want to correct this as soon as possible.

Additionally, I would like to safeguard against any further incidents such as this and would like any recommendations from you. Many of my clients do not receive their annual reports each year. Some forms are sent to my office as I am the registered agent. Please advise me whether the annual report forms are sent to the principal place of business or the registered agent as we were informed that the 1998 Annual Report for this client was mailed to my name at their address; consequently, it was returned to you as I have never been at their address.

We greatly appreciate your consideration and timely response to our request to waive the reinstatement fee.
