**ARTICLE I  
Name**

The name of the corporation is **CONSTANT FINANCIAL, INC.**

**ARTICLE II  
Duration**

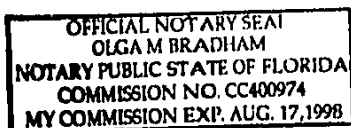
