**ARTICLES OF INCORPORATION OF

The undersigned, acting as a subscriber of a corporation under the Florida General Corporations Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I--NAME AND ADDRESS

The name of the corporation shall be Ana M. Jhones, P.A., at 330 Biscayne Boulevard, Suite 310, Miami, Florida.

ARTICLE II--PURPOSE

The purpose of this corporation is to engage in the practice of law and to exercise the powers now or hereafter granted to Professional Service Corporations.

ARTICLE III--DURATION

The corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE IV--CAPITAL STOCK

A. The maximum number of shares of stock that this corporation shall have the authority to have outstanding at any time shall be One Thousand (1,000) shares of Common Stock at One Dollar (\$1.00) per share.

B. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.

C. Share of the corporation's stock and certificates shall be issued only to attorneys

in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.

ARTICLE V--INITIAL BOARD OF DIRECTORS

The number of Directors constituting this corporation's initial Board of Directors is one (1) person, whose name is: Ana M. Jhones, 330 Biscayne Boulevard, Suite 310, Miami, Florida 33132.

ARTICLE VI--INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of the corporation is 330 Biscayne Boulevard, Suite 310, Miami, Florida 33132. The name of the Registered Agent is Ana M. Jhones.

ARTICLE VII--INCORPORATOR

The name and address of the person signing these Articles is Ana M. Jhones, 330 Biscayne Boulevard, Suite 310, Miami, Florida 33132.

ARTICLE VIII--SEVERANCE AND TERMINATION OF EMPLOYMENT

If any officer, director, stockholder, agent or employee of this corporation becomes legally disqualified to render the professional services for which the corporation is organized, or accepts employment that places restrictions or limitations on his continued rendering of such professional services, he shall forthwith sever all employment with the corporation, and shall not thereafter participate or share, directly or indirectly, in any earnings or profits realized by the corporation on account of professional services. The corporation shall forthwith, upon such disqualification of any shareholder, purchase such

shareholder's shares and pay him all amounts owing and lawfully due to him by the corporation, except that such shares shall not be entitled to dividends.

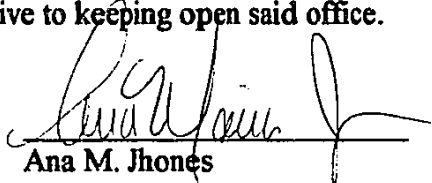
ACCEPTANCE OF DESIGNATION OF REGISTERED AGENT
