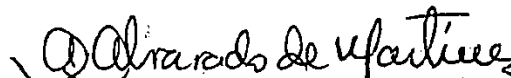

**ARTICLE ONE:
NAME**

The name of the Corporation shall be Personal Actualization Center, Inc.

**ARTICLE TWO:
LOCATION**

The location of the principal office of the Corporation shall be : 9984 Nob Hill Place,
Sunrise, Florida 33351.

**ARTICLE THREE:
PURPOSE**

The Purpose of the Corporation shall be to provide high quality hypnosis therapeutic services and training for professionals who want to enter or further their careers in the field of hypnosis. ARTICLE SIX: CORPORATE STOCK

The stock of the Corporation shall consist of one thousand (1,000) shares at one dollar (\$1.00) par value. The stock of the corporation shall be distributed as follows:

Aura Margarita Torrealba - Fifty percent (50%) of the shares.

ARTICLE SEVEN DURATION

The duration of the Corporation shall be perpetual.

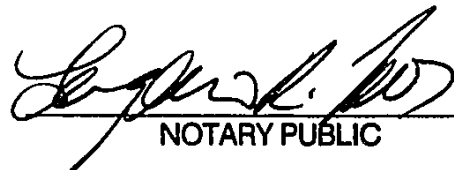

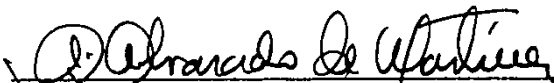
