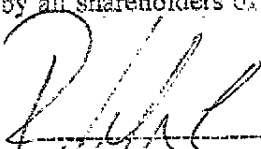

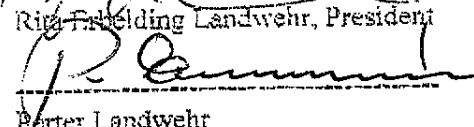
1. The name of the Corporation is EUROPEAN INTERIOR DESIGN, INC.

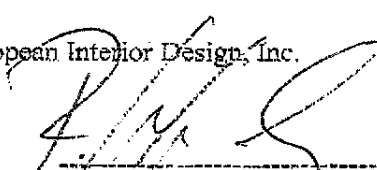

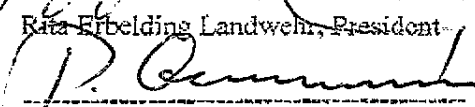
