We request that you waive the reinstatement fee, and offer the following rational for such request:

B. E. L. Consultants, Inc. is a small consulting company that I operate out of my home. I sold the home at 13 Via Marino in the fall of 2002 and operated out of rented facilities until June of 2003 when I moved into a new home at 7 Avenue de la Mer #604 in Palm Coast. The above postal address was opened in October 2002 to avoid the problems normally associated with relocation.

The Post office did not forward all of the mail to the postal box as directed by the change of address information provided to them. The new owner of 13 Via Marino is a part time resident. The new owner called this week to inform me that he found mail for B.E.L. Consultants in his mailbox, and that he would leave it there for me to pick up, since he was again leaving town. Apparently, this has happened before, since we have not received prior UBR notices.
