THE UNDERSIGNED SUBSCRIBERS TO THESE ARTICLES OF INCORPORATION, EACH A NATURAL PERSON COMPETENT TO CONTRACT, HEREBY ASSOCIATE THEMSELVES TOGETHER TO FORM A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA.

SECTION 1.01 NAME. THE NAME OF THIS CORPORATION IS:
NAVAS EXPRESS CORP.

SECTION 2.01 CAPITAL STOCK. THE MAXIMUM NUMBER OF SHARES OF PAR VALUE COMMON, OF NON PAR COMMON AND OF PREFERRED STOCK, AND OF EVERY KIND, CLASS OF SERIES OF EACH, WITH THEIR DISTINGUISHING CHARACTERISTICS AND THE PAR VALUE OF ALL SHARES HAVING PAR VALUE THAT THIS CORPORATION IS AUTHORIZED TO HAVE OUTSTANDING AT ANY ONE TIME IS: **500 SHARES COMMON STOCKS \$1.00 PAR VALUE EACH**

SECTION 9.01 TO ENGAGE IN EVERY ASPECT AND PHASE OF THE BUSINESS OF:
ANY AND ALL BUSINESS WHICH IS NOT CONTRARY TO THE LAWS OF THE UNITED STATES OF AMERICA AND OF THE STATE OF FLORIDA.

SECTION 9.02 TO MANUFACTURE, PURCHASE OR OTHERWISE ACQUIRE, AND TO OWN, MORTGAGE, PLEDGE, SELL, ASSIGN, TRANSFER, OR OTHERWISE DISPOSE OF AND TO INVEST IN, TRADE IN, DEAL IN AND WITH, GOODS, WARES, MERCHANDISE, REAL AND PERSONAL PROPERTY AND SERVICES, OF EVERY CLASS, KIND AND DESCRIPTION: EXCEPT THAT IT IS NOT TO CONDUCT BANKING, SAFE DEPOSIT, TRUST, INSURANCE, SURETY, EXPRESS, RAILROAD, CANAL, TELEGRAPH, TELEPHONE OR CEMETERY COMPANY, A BUILDING AND LOAN ASSOCIATION, MUTUAL FIRE INSURANCE ASSOCIATION, COOPERATIVE ASSOCIATION, FRATERNAL BENEFIT SOCIETY, STATE FAIR OR EXPOSITION.

SECTION 9.03 TO CONDUCT BUSINESS IN, HAVE ONE OR MORE OFFICES IN, AND BUY, HOLD, MORTGAGE, SELL, CONVEY, LEASE OR OTHERWISE DISPOSE OF REAL AND PERSONAL PROPERTY, INCLUDING FRANCHISES, PATENTS, COPYRIGHTS, TRADEMARKS, AND LICENSES, IN THE STATE OF FLORIDA AND IN ALL OTHER STATES AND COUNTRIES.

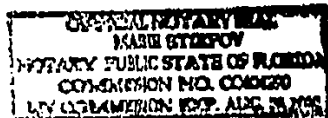
