I, THE UNDERSIGNED HEREBY ASSOCIATE TOGETHER FOR THE PURPOSE OF FORMING A CORPORATION BY AND UNDER THE PROVISIONS OF THE LAWS OF THE STATE OF FLORIDA OF THE UNITED STATES OF AMERICA PROVIDING FOR THE FORMATION, LIABILITY, RIGHTS, PRIVILEGES AND IMMUNITIES OF A CORPORATION FOR PROFIT, AND DO HEREBY ADOPT, MAKE, SUBSCRIBE, CERTIFY, ACKNOWLEDGE AND FILE THE FOLLOWING ARTICLES OF INCORPORATION:
