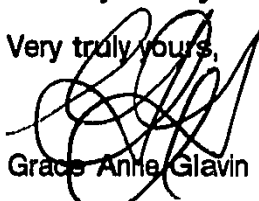

ARTICLES OF INCORPORATION
FOR
M S REPROGRAPHICS, INC.

The Undersigned, acting as incorporators of this business corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a Business Corporation under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be M S REPROGRAPHICS, INC.

ARTICLES II - TERM OF EXISTENCE

This corporation shall begin its corporation existence as of the 1st day of January, 1997, and shall exist perpetually.

ARTICLES III - GENERAL PURPOSE

The general purpose for which this corporation is organized shall be preparation of blueprints, photocopying and related products and services and to do all things in connection therewith under the laws of the State of Florida. The business of the corporation shall be limited to the foregoing activities.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is Seven thousand Five Hundred (7,500) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE V

REGISTERED OFFICE, REGISTERED AGENT AND PRINCIPAL OFFICE

The street address of the initial Registered Office of the corporation in the State of Florida will be 1340 Tuskawilla Road, Winter Springs, Florida 32708, and the name of the initial Registered Agent as such address is GRACE ANNE GLAVIN, ESQUIRE.

ARTICLE VI - DIRECTORS AND INCORPORATION

A. The initial number of Directors of this corporation shall be two (2).

B. The number of Directors may be increased or diminished from time to time with by-laws adopted by the shareholders, but shall never be less than one.

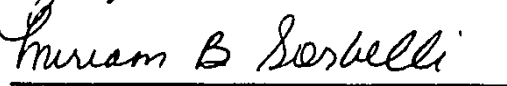
ARTICLE VII - AMENDMENT TO ARTICLES
