ARTICLE I

The name of the corporation is I.O.T., INC.

ARTICLE II - PURPOSE

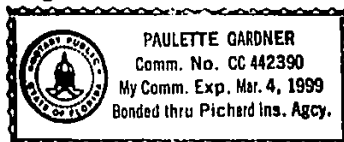
