The undersigned, Richard Gibbs, subscriber and incorporator to these Articles of Incorporation, as a natural person competent to contract, hereby present these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME


