The undersigned, for the purpose of forming a corporation under BerFlorida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name and Address

The name of the Corporation is R. M. Produce, Inc. The principal office, if known, or the mailing address of the Corporation is 6637 Middlesex Place, Naples, Florida 34104.

Article 2. Duration

The duration of the Corporation is perpetual.

Article 3. Purpose

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
