I, the undersigned, being a natural person of legal age, do hereby desire to form a Corporation under the Laws of the State of Florida, and do hereby adopt the following Articles of Incorporation.

- 1. NAME. The name of the Corporation shall be VIVA HOSPITALITY COMPANY, a Florida Corporation.
- 2. PRINCIPAL OFFICE OR MAILING ADDRESS. The Principal Office of the corporation shall be and its mailing address shall be 2809 Jacana Court, Longwood, Florida 32779. The Principal Office and mailing address may be changed from time to time by the Board of Directors.
- 3. **STOCK.** The amount of total authorized capital stock of this Corporation is Twenty Million (20,000,000) shares of common stock having a par value of \$.01 per share and Ten Million (10,000,000) shares of Preferred Stock of a par value of \$.01 per share. The Board of Directors of this Corporation is authorized to prescribe, fix or alter the classes, series, designations, preferences, voting powers, limitations and relative rights of each class or series of this Corporation's stock and to determine and fix the consideration to be paid for each share.

negligence or willful and wanton misconduct in the performance of his or her duties as such Officer, Director, employee or agent. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such Director, Officer, employee or agent may be entitled.

9. AMENDMENT. The Corporation reserves the right to amend, alter, change, repeal and revise any of the provisions of this Corporation's Articles of Incorporation in the manner now, or hereafter prescribed by statute and all rights conferred on shareholders herein are granted subject to this reservation.
