ARTICLES OF INCORPORATION  
OF

ALVAVACA, INCORPORATED

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation" = Alvavaca, incorporated.

ARTICLE II

The existence of the corporation shall begin on January 7, 1997.

ARTICLE III

The street address of the principal office of the Corporation is 370 S. State Road 7, Hollywood, Florida, 33023.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares. 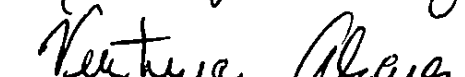
