## ARTICLES OF INCORPORATION

<u>OF</u>

# TURTLE AUTOMOTIVE GROUP, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: TURTLE AUTOMOTIVE GROUP, INC., whose initial business address is 1575 S. Hwy 17-92, Longwood, Florida 32750.

Article 2. Duration The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:

To engage in and transact any lawful business for A. which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

в. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

C. To generally and initially deal in the retail sale of automotive services, maintenance, and repair; together with other related automotive services including retail sale of parts and supplies and engine replacement.

Article 4. Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is 7500 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

Article 8. Amendment. The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.

Article 9. Indemnification. The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.

Article 10. Rights of Initial Directors.
