*Pursuant to the provisions of Section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:*

FIRST: Article One:

The corporation name is changed from Dermatology Consulting, Inc. to Dermatology Consulting, P.A.

SECOND: The nature of the business is providing veterinary dermatology consultations to veterinary patients by referral from other veterinary medicine practitioners and providing treatment for dermatological problems with animals.

THIRD: The date of the amendment's adoption is : June 25, 1999.
