The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

Jet Partners Inc.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and this State.

ARTICLE III

The total authorized capital stock of this corporation shall be 1000 shares of par value common stock. All stock shall be fully paid for in lawful money of the United States or in property, labor or services at a par valuation of \$1.00 per share.

ARTICLE IV

The amount of capital with which this corporation will begin business shall be no less than \$1000.00

ARTICLE V

This corporation is to exist perpetually.

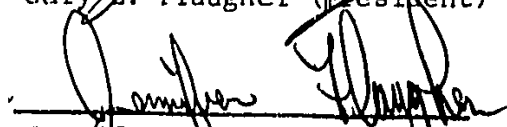

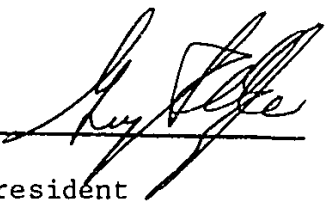

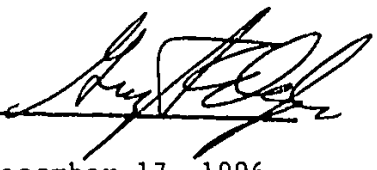
