ARTICLES OF INCORPORATION

The undersigned natural person of the age of twenty-one (21) years or more, acting as incorporator of a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE 1 -NAME

The name of this Corporation is Contemporary Promotional Products, Inc. (hereinafter called the "Corporation").

ARTICLE II - EFFECTIVE DATE AND DURATION

The Corporation will have an effective date of January 6, 1997 and will exist for a perpetual period.

ARTICLE III - PURPOSE
