We have recently received the records for Zika Enterprises, Inc. After a short review of the records, it has come to our attention that the corporation has been dissolved by the State.

We strongly believe there is reasonable cause for waving of the reinstatement fees. Please read the following information:

It appears that the annual report for 1998 was sent in by April 17, 1998 (copy of cover page enclosed). Check #1001 was sent in with the report but appears to have not been cashed. The only logical conclusion we can come up with, is that the report was sent back.

The address on the Annual Report was 122 Isles of Venice, Ft. Lauderdale, Fl 33301. This address was the address of Joanna C. Peragine, an accountant. This individual was retained by Zika Enterprises, Inc. to handle all affairs in the United States concerning the corporate records (limited power of attorney enclosed). The annual report was probably returned to this person. Joanna's company was paid in advance for all that was necessary. Joanna Peragine passed away shortly afterwards unknown to Mr. Zika of Zika Enterprises, Inc., at that time.

There was very little activity in the first year and one half in Zika Enterprises. The owner, Mr. Zika, lives in Austria and did not know anything was wrong with his records. He was under the impression all was in order. Well that was not the case.

We have recently received the records and are just now preparing all the tax returns necessary to put things back in order.

The corporation has had very little activity in 1998 and 1999. However Mr. Zika would like to reinstate the corporation if the fees were with in reason. We have enclosed two checks for the annual fees in the amounts of \$150 each, to place the corporation back in active status.
