ARTICLES OF INCORPORATION

OF

I, the undersigned, acting as the Incorporator of a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of this corporation is Integrated Data Solutions, Inc. The prinicple location of the corporation is 1863 Country Meadows Drive, Sarasota, FL 34235.
