ARTICLES OF INCORPORATION

OF

SCHANER ENTERPRISES, INC.

I, the undersigned, acting as the Incorporator of and corporation under the Florida General Corporation Act, derived hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of this corporation is Schaner Enterprises, Inc. The prinicple location of the corporation is 14529 Anchorage Cir., Seminole, FL 33776.

ARTICLE II. DURATION

The duration of the corporation shall be perpetual, and its corporate existence shall commence upon the filing of these Articles of Incorporation.
