

ARTICLES OF INCORPORATION OF MARK ANTHONY ARIAS, P.A.



The undersigned hereby makes, subscribes, acknowledges and files with the Secretary of State of Florida these articles of incorporation for the purpose of forming a professional service of LURIDA corporation for profit in accordance with the laws of the State of Florida.

ARTICLE 1 - NAME

The name of the Corporation shall be: MARK ANTHONY ARIAS, P.A.

ARTICLE - II

The Corporation shall have perpetual existence.

ARTICLE - III

The general purpose of the business to be transacted by this Corporation is:
