



ARTICLE I. NAME

ARTICLE IX. SPECIAL PROVISIONS

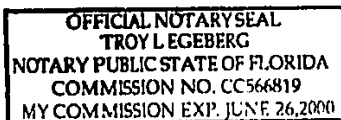
