ARTICLES OF AMENDMENT
TUMBLE BUS OF FORT MYERS INC.

The undersigned, for the purposes of amending the corporation's articles of incorporation, filed with the Secretary of State on January 16, 1997, states:

1. The undersigned is the sole incorporator of this corporation.
2. The corporation has not yet issued any stock.
3. The sole incorporator, by resolution on February 22, 1997, adopted the following amendment to the Articles of Incorporation:

ARTICLE I. NAME is amended by deletion of the words "FORT MYERS" and the substitution of the words "SOUTHWEST FLORIDA" in their place.


4. The result of this amendment is to change the name of the corporation from "TUMBLE BUS OF FORT MYERS, INC." to "TUMBLE BUS OF SOUTHWEST FLORIDA, INC."
5. The amendment was approved and adopted by the sole incorporator on a date at which there were no shareholders and accordingly, shareholder action was not required. (677.1005 F.S.)
