ARTICLE I

NAME

PURPOSE

This corporation is organized to engage in any and all lawful business activity permitted under the laws of the State of Florida.

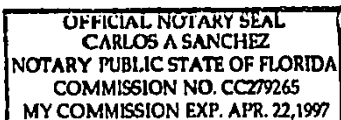
