ARTICLE I - NAME

The name of this corporation is **WORLDWIDE SECURITY, INC.**

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLES IV - PURPOSE

This corporation is organized for the purpose of providing domestic and commercial security services.
