**ARTICLES OF INCORPORATION  
OF  
WEBWEAVER PRODUCTIONS, INC.**

EFFECTIVE DATE

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation shall be WebWeaver Productions, Inc.

**ARTICLE II. PRINCIPAL OFFICE**

The initial principal office of the corporation shall be located at, and the mailing address of the corporation shall be, 3451 N. Blue Angel Parkway, Pensacola, Florida 32526.

**ARTICLE III. TERM OF EXISTENCE**

The corporation is to exist perpetually commencing on the 10th day of January, 1997.

**ARTICLE IV. CAPITAL STOCK**

The corporation is authorized to issue 7500 shares of One Dollar (\$1.00) par value common stock.

**ARTICLE V. INITIAL REGISTERED AGENT AND ADDRESS**

**ARTICLE VII. DIRECTORS**

The corporation shall initially have one director. The number of directors may be increased or decreased from time to time by the bylaws, but shall never be less than one. The initial director of the corporation shall be Michael R. Beaver, whose address is 3451 N. Blue Angel Parkway, Pensacola, Florida 32526.

**ARTICLE VIII. CUMULATIVE VOTING**

At each election for directors every shareholder entitled to vote at that election shall have the right to cumulate his or her votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of shares owned by the shareholder, or by distributing those votes on the same principle among any number of candidates.

**ARTICLE IX. AMENDMENT**

The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.
