The undersigned incorporator, being a natural person competent to contract, hereby adopts these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this Corporation is SPACE COAST POOL & SPA SUPPLIES, INC.

ARTICLE II

This Corporation shall commence upon the execution of these Articles and shall exist perpetually.

ARTICLE III

The purpose of this Corporation is to operate a swimming pool and spa service and supply business, and engage in any business lawful under the laws of the State of Florida or the United States.
