The undersigned incorporator, DEBORAH J. TRAFICANT - BERGMAN, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

1. The name of the corporation shall be:

TESCO SLIDE-AWAY, INC.

2. The general purpose for which the corporation is initially organized is the transaction of any and all lawful business for which corporations may be incorporated, including the fabrication of a slide-away tool device under Chapter 607.164 of the Florida Statutes.
