ARTICLE ONE

The name of the corporation is **AUGUSTO DELIVERY, INC.** The principal address of the corporation is: **6808 N.W. 78th Court, Tamarac, Florida 33321.**

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations maybe incorporated under the Florida Corporation Act.
