I, the undersigned, acting as incorporator of a corporation under the Florida Professional Service Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I - Name

The name of the corporation is KARL W. BOHNE, JR., P.A.

ARTICLE II - Duration

The period of duration of the corporation is perpetual.

ARTICLE III - Purpose

The purpose or purposes for which the corporation is organized are to engage in the practice of law as a professional service corporation under the authority of the Florida Professional Service Corporation Act, and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other law, or by these Articles of Incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district or possession of the United States, or by the foreign country.

ARTICLE IV - Capital Stock

This corporation is authorized to issue 1,000 shares of One Dollar (\$1.00) par value common stock.

ARTICLE V - Registered Office and Agent

ARTICLE VI - Initial Board of Directors

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

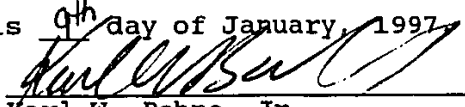
ARTICLE IX - Amendment

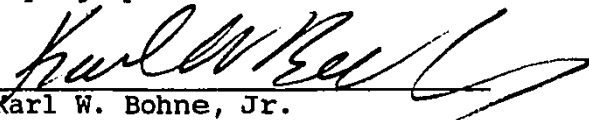
