## ARTICLES OF INCORPORATION

OF

### AWESOME AWNINGS INC.

I, the undersigned, hereby present myself for the purpose of becoming a corporation under the law of the State of Florida.

**FIRST:** The name of the corporation is **AWESOME AWNINGS INC.**

**SECOND:** The office of the corporation is located at 4805 N. Manhattan, Tampa, Florida 33614.

**THIRD:** The purpose for which the corporation is formed is to manufacture and market awnings and any other legal purposes.

**FOURTH:** The amount of shares of stock which the corporation shall have is One Hundred (100) shares at One Dollar (\$1.00) par value per share.

**FIFTH:** The amount of capital with which the corporation shall begin business will be One Hundred Dollars (\$100.00).

**SIXTH:** The entire voting power for the selection of the Directors and for all other purposes shall be vested exclusively in the holders of the common stock of the corporation.

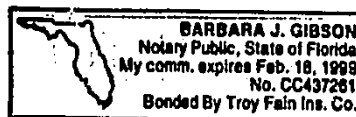

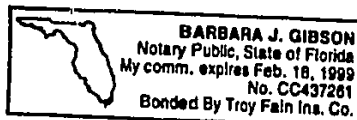
