ARTICLES OF DISSOLUTION
OF
CHANCELLOR-ASC, INC.

The undersigned, CHANCELLOR-ASC, INC. , a Florida corporation, desires to dissolve its corporate status pursuant to Sections 607.1402(6) and 607.1403 of the Florida Business Corporation Act, and hereby states as follows:

ARTICLE I - NAME OF CORPORATION

The name of the corporation is CHANCELLOR-ASC, INC. (hereinafter referred to as the "Corporation").

ARTICLE II - DATE OF AUTHORIZATION

These Articles of Dissolution were adopted by the holder of all of the outstanding shares of common stock of the Corporation, as the sole voting group of the Corporation, by a unanimous written consent executed on September 1, 1997, which constituted a sufficient vote for approval by the sole shareholder.
