**ARTICLES OF INCORPORATION**  
**OF**  
**C. KUHLMAN & ASSOCIATES, INC.**

The undersigned, desiring to form a corporation for profit pursuant to the laws of the State of Florida, do hereby certify as follows:

**ARTICLE I**

The name of the corporation shall be:

**C. Kuhlman & Associates, Inc..**

**ARTICLE II**

The Corporation shall be entitled to engage in any activity permitted under the laws of the State of Florida.

**ARTICLE III**

The capital stock of the corporation shall be divided into shares of \$0.25 par value, with 500 shares of common authorized, and each share shall entitle the holder thereof to vote at any meeting of the shareholders. All or any part of said capital stock may be paid for in cash, with property or in labor or services, at a valuation fixed by the incorporators or by the board of directors, at a meeting called for such purpose. All stock when issued shall be fully paid for and shall be nonassessable.

#### **ARTICLE IV**

The amount of capital with this corporation shall begin business will be a minimum of \$100.00.

#### **ARTICLE V**

The Corporation shall have perpetual existence.

#### **ARTICLE VI**

The principal office of the Corporation shall be located at 14168 Fennsbury Drive Tampa, Florida. 33624 but the Corporation shall have power to establish branch offices and other places of business at such other places within or without the State of Florida, as may be determined and deemed expedient by the Directors.

#### **ARTICLE VII**

The board of directors of the Corporation Shall not be less than one (1) nor more than (7) unless otherwise provided by the By-Laws. A quorum for the transaction of business shall be a majority of Directors qualified and acting unless otherwise provided in the By-Laws. The directors may make or amend the By-Laws: the meeting of Directors may be held within or without the State of Florida. A person shall not have to be a stockholder in order to qualify as a Director.

## ARTICLE IX

The time and place of the annual stockholders meeting shall be on January 1<sup>st</sup> of each  
and every year at the principal office of the Corporation unless otherwise fixed in the By-  
Laws or the resolution of the Board Of Directors and any stockholder may waive notice  
thereof before or after the meeting.

The Board of Directors shall be elected annually by Stockholders at their annual  
meeting or at a special meeting held for the purpose. All vacancies in the Board shall be  
filled by the Board until the next annual meeting and the Board shall have the right to  
increase or decrease its number of Directors within the limits of this Charter.



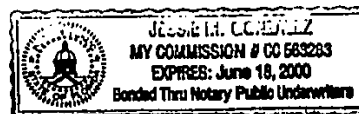
