ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this corporation is WAYNE WICKER, INC., whose address is 34001 Highland Road, Leesburg, Florida 34788.

ARTICLE II. COMMENCEMENT OF EXISTENCE

This corporation shall begin its existence on the date of filing of these Articles of Incorporation.

ARTICLE III. DURATION

The term of existence of the corporation is perpetual.

ARTICLE IV. PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE V. CAPITAL STOCK
