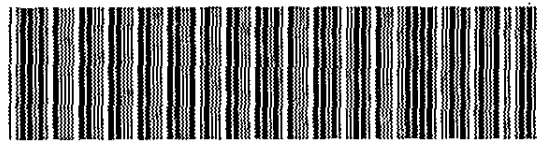

Article IV


These Articles of Dissolution will take effect on the October 31, 2002, at 5:00 P.M.
