The undersigned, as President of DOMINA DEVELOPMENT, INC., Florida corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to Section 607.1006 of the Florida Business Corporation Act (the "ACT"), states as follows:

1. The current name of the Corporation is DOMINA DEVELOPMENT, INC.

2. The date of the filing of the original Articles of Incorporation of the Corporation was January 21, 1997.

3. The Articles of Incorporation of the Corporation are amended by deleting Article I entitled "Name" in its entirety and inserting the following section in its place and stead:

ARTICLE I - NAME

The name of this corporation is CORONADO DEVELOPMENT, INC.
