ARTICLES OF INCORPORATION
OF

LIAQAT ZAMAN, P.A.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is LIAQAT ZAMAN, P.A.

ARTICLE II

This corporation shall be perpetual in existence.

ARTICLE III

Liaqat Zaman, P.A., shall be organized for the business of medical practice.

ARTICLE IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred shares of common stock, each share having a par value of \$1.00 (one dollar).

ARTICLE V

The names and street addresses of the subscribers to these Articles of Incorporation are as follows, together with the initial stock ownership, for which the subscribers shall give a consideration to the corporation equal to the par value of their shares:

ARTICLE VI

Liaqat Zaman, P.A., shall apply for S corporation status and shall maintain its affairs in such a way that it qualifies for S corporation status.

ARTICLE VII

If a shareholder wishes to sell any or all of his shares in Liaqat Zaman, P.A., he must first try to sell the shares to another shareholder. He shall deliver via the mail, nongovernmental delivery service, personally hand-deliver, or hand-deliver through an agent, to each other shareholder a declaration of intention to sell the number of shares he wants to sell. The other shareholders have twenty days in which to convey to the seller their intention to buy all or part of the shares for sale. The twenty days shall be counted from the day on which the last shareholder to receive the declaration has received it.

If after the expiration of twenty days no shareholder has declared an intention to buy the shares, or the price offered is unacceptably low to the seller, the seller may sell them to any person or business entity, subject to a majority vote of approval by the shareholders. The shares for sale shall not have voting rights in this matter.

A shareholder may bequeath his shares to his legal heirs. If the deceased shareholder has left no heir, his shares shall be sold by the executor of his estate according to the procedure described in the previous paragraph.

ARTICLE VIII

ARTICLE IX

The directors of the corporation shall be the incorporators. Dr. Liaqat Zaman shall be the initial Chairman of the Board of Directors.

ARTICLE X

The officers shall consist of a president, a vice-president, a secretary, and a treasurer. All positions other than president and vice-president may be vested in the same individual.

ARTICLE XI

The following methods of casting votes for any amendment, resolution, or matter before the Directors or officers shall be valid:

In case of the voters being physically present: show of hands, oral voting, or written voting.

In case of the voters not being physically present: voting by fax, by E-mail, and by phone.

However, for amendments to the Articles of Incorporation, Bylaws, or any matter having legal ramifications, original or faxed signatures of those voting shall be subsequently collected and maintained in the corporate records.

ARTICLE XII

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved at a stockholders' meeting by a majority of the stock, each share having one vote.
